LAST YEAR WE RESCUED 1104 HOMELESS DOGS AND CATS. OUR SHELTER SERVES AS A LEARNING CENTER FOR THE COMMUNITY AS OUR STATE-OF-THE-ART FACILITY IS A PLEASANT, FRIENDLY, QUIET PLACE FOR PEOPLE TO GO TO SEE ANIMAL INTERACTIONS AND POSITIVE BEHAVIORS MODELED IN THE DAILY ROUTINES. EVERY DOG AND CAT IN THE CARE OF SANTA MARIA VALLEY HUMANE SOCIETY LEARNS BASIC MANNERS, HOUSETRAINING, AND SOCIAL SKILLS TO BECOME A SUCCESSFUL NEW FAMILY MEMBER. IT IS NOT UNCOMMON FOR AS MANY AS 100 HOMELESS ANIMALS PER NIGHT TO SEEK REFUGE AND SAFETY IN OUR SHELTER. LAST YEAR, 1010 HOMELESS DOGS AND CATS FOUND NEW HOMES
